## Floor space rental

The floor space rental fee per square meter is:

## Participation

Only exhibits of goods and services which are relevant to the mushroom industry are allowed.

The organizer will judge the relevance and safety of the exhibits for the mushroom industry and will also determine the number of stands exhibiting the (same) products and services. Goods and services which have been determined as unsafe or which may show technical flaws shortly after the start of use, for the consumers or visitors of the event, as determined by a well-respected and recognized research organization, will not be allowed.

## Payment Terms

On registration, Champignonndagen 2023 will charge 25% of the participation costs, paid in full immediately or before December 16<sup>th</sup> 2022. The other 75% of the participation costs must be paid in full by direct debit before January 15<sup>th</sup> 2023, which will also be specified in the invoice. The amount thereafter still due (relating to other costs) must be paid in full by direct debit within two weeks of the date on the final allocation invoice.

## Cancellation rules

In case of cancellation of participation by the exhibitor the following payment obligations apply:

- 25% of the participation costs in the event of cancellation of the registration after receipt by Champignonndagen 2023 of the binding registration form (before December 16<sup>th</sup> );
- 100% of the participation costs in the event of cancellation after January 15<sup>th</sup> 2023, plus the VAT owed, as well as other costs incurred, and (in)direct damage, at the discretion of Champignonndagen 2023.
