

## *GENERAL*

### Article 1 Definitions

In these regulations, the following terms shall have the following meanings:

1. Mushroom Days: Champignon Exhibitions BV, being the organizer of Mushroom Days 2026;
2. Exhibitor: the exhibitor who has entered into a participation agreement with Mushroom Days;
3. Brabanthallen: the lessor of the accommodation where Mushroom Days 2026 will be held;
4. Binding registration form: the digital registration form with which the exhibitor has entered into the participation agreement;
5. Participation agreement: agreement between Mushroom Days and the exhibitor, which is the result of a corresponding intention between the parties, as evidenced by the receipt by Mushroom Days of the binding registration form participation completed online by the exhibitor and the subsequent confirmation by Mushroom Days to the exhibitor by e-mail of his participation in Mushroom Days 2026;
6. Mushroom Days 2026: the event for which the participation agreement has been concluded;
7. Articles: the articles exhibited and/or services provided by the exhibitor at Mushroom Days 2026;
8. Stand space: the exhibition area expressed in square meters made available to the exhibitor, of which the location and form are specified by Mushroom Days;
9. Participation costs: the costs owed by the exhibitor to Mushroom Days in connection with his participation, including costs relating to the stand space, cancellation payments, any costs relating to the engagement of third parties, publicity and other costs.

### Article 2 The participation agreement

1. The tenderer declares that he accepts all the consequences of signing this binding registration form, even if the signature is made by a person not authorized to sign.
2. After the exhibitor has completed and sent in the binding participation form and before the formation of the participation agreement in accordance with article 1 paragraph 5, the term "participation agreement" in these regulations is to be read as "binding participation form".
3. Mushroom Days reserves the right to reject an application on the grounds of oversubscription, when the category concerned is full, special reasons such as fear of disturbance of the peace, not fitting in the concept of the event or any other reason to be determined by Mushroom Days.
4. The tenderer may not rely on the fact that his tender was accepted orally.
5. The tenderer shall not be entitled to assign his tender to a third party.
6. These regulations form an integral part of the participation agreement concluded between the exhibitor and Mushroom Days.
7. Deviations from these regulations or full or partial exemptions from any prohibition or obligation contained in these regulations shall only be effective if the deviation or exemption is explicitly stated in a document signed by Mushroom Days and/or if supplementary or deviating regulations have been declared applicable.
8. These regulations apply to the legal relationship between Mushroom Days and the exhibitor. Unless otherwise stipulated, third parties cannot derive any rights from these regulations.

### Article 3 Dates and duration

1. Mushroom Days sets the location and time of Mushroom Days 2026, including the dates for the buildup, holding and dismantling. For this, see the webshop, also known as the digital handbook. Every participant will receive an invitation including log-in details.
2. If, in the opinion of Mushroom Days, there are weighty reasons for doing so, Mushroom Days is entitled to change the dates and/or location, or to decide that Mushroom Days 2026 will not be held.

3. A weighty reason as referred to in the previous subsection is understood to mean market circumstances and all other circumstances which, after weighing up the interests, in the opinion of Mushroom Days, could jeopardize the success of Mushroom Days 2026 (including, but not limited to, the absence of the necessary permits and/or dispensations and/or non-compliance with the zoning plan and/or restrictions and/or uncertainties caused by a possible pandemic and/or wars and/or other (economic) crises) and/or insufficient applications.
4. In the event of a change in the dates and/or location as referred to in subsection 2 of this article, the participation agreement remains in full force and effect. In the event that Mushroom Days decides to cancel the 2026 exhibition, the exhibitor is obliged to pay the full participation costs and other costs made at his request by or on behalf of Mushroom Days. In that event, Mushroom Days shall endeavor to refund the costs paid by the exhibitor, for which no costs have yet been incurred by Mushroom Days, in proportion to the number of square meters of floor space rented, on the understanding that Mushroom Days is not obliged to refund if this would result in a deficit for Mushroom Days in the running of Mushroom Days 2026.
5. In no event shall the exhibitor be entitled to dissolve the participation agreement or to claim damages from Mushroom Days in connection with a decision as described in subsection 2 of this article, nor shall he be entitled to claim reimbursement of any costs incurred or restitution of monies paid by Mushroom Days.

#### Article 4 Allocation

1. Participation in Mushroom Days 2026 does not entail exclusivity for the exhibitor, neither in terms of product group nor in terms of the concept of exhibition activities at Mushroom Days 2026.
2. During the agreed period, the exhibitor is entitled to the stand space determined by Mushroom Days. The location and size of the stand space determined by Mushroom Days is binding. Cancellation can only take place on the basis of article 7.
3. In determining the location and size of the stand space as referred to in subsection 2, Mushroom Days will take into account as far as possible any wishes expressed by the exhibitor. This is a best-effort obligation and not a result obligation. Mushroom Days is never obliged to honour the preference(s) indicated by the exhibitor and can allocate stand space as it deems fit. Cancellation by the exhibitor can only take place on the basis of article 7.
4. Mushroom Days is entitled at any time before the start of Mushroom Days 2026 to change the location allocated to an exhibitor on the grounds of weighty reasons, as determined by Mushroom Days. The exhibitor is not entitled to compensation for any damage whatsoever, direct or indirect, in connection with the provisions of this paragraph.

#### Article 5 Payment

1. Payment of the participation costs and all other payments must be made by direct debit, unless other arrangements have been made.
2. Registration for the Mushroom Days is possible until 15 November 2025 at the latest. On 15 November 2025, Mushroom Days will charge 25% of the participation fee. This amount must be immediately paid in full by the exhibitor. As will also be indicated on the invoice, the remaining 75% of the participation fee must be paid on 15 December 2025. The amount still due thereafter (in connection with other costs) must be paid in full within 4 weeks after the final invoice.
3. The exhibitor is liable for all participation costs owing to Mushroom Days which are in any way connected with his participation, including costs made by the exhibitor himself or by third parties acting in his name.
4. In the event of late payment of any amount owed to Mushroom Days, statutory (commercial) interest will be charged from the moment the claim has become due and payable. Collection costs are for the account of the exhibitor and the extrajudicial collection costs are set at 15% of the principal sum.
5. Mushroom Days is entitled to deduct payments made in respect of a participation from outstanding claims on the part of the exhibitor arising from previous participations.
6. In the event that the exhibitor fails to pay the participation costs or any other amount owed to Mushroom Days in part or in full or on time, Mushroom Days is entitled to terminate the participation agreement with immediate effect in writing. In such case, the exhibitor is obliged to pay the full participation costs,

as well as all other costs incurred in connection with his participation, without being entitled to claim compensation for damages, in whatever sense, due to the termination.

#### Article 6 Additional services

1. Mushroom Days can offer additional services for Mushroom Days 2026, such as compiling a catalogue, providing various forms of publicity and organizing various activities. These regulations apply mutatis mutandis to the relevant agreement(s) concluded. If third parties are called in to provide these services, the terms of delivery of these third parties do not apply, unless otherwise stipulated.
2. If and insofar as applicable, Mushroom Days determines the way in which entries are edited and reserves the right, if necessary, to shorten the exhibitor's details or deviate in any other way from the exhibitor's statement, if necessary without giving reasons. If the exhibitor mentions articles and/or services offered by him in his publicity statements, he may only mention those articles and/or services which both fall within his delivery program and which - in the opinion of Mushroom Days - belong to the approved exhibition program.
3. Unless intent or gross negligence can be attributed to it, Mushroom Days accepts no liability towards the exhibitor or third parties for the provision of additional services. The exhibitor indemnifies Mushroom Days against claims from third parties in this respect.

#### Article 7 Cancellation, dissolution

1. If the exhibitor cancels his registration and there is no question of a situation as referred to in paragraphs 2 or 3 of this article, the exhibitor owes the following cancellation fee to Mushroom Days:
  - 25% of the participation costs in the event of cancellation of the registration after payment of the first term (on or about 15 November 2025).
  - 100% of the participation costs in the event of cancellation of the registration after 15 December 2025.
2. In the event that at any time after the conclusion of the participation agreement, a petition for suspension of payments or bankruptcy is filed with regard to the exhibitor, the participation agreement shall be dissolved by the mere occurrence of the aforementioned petition and the exhibitor shall remain liable to pay the full amount of the participation costs and any other costs incurred by or on behalf of Mushroom Days in connection with his participation at the request of Mushroom Days, without prejudice to the right of Mushroom Days to claim costs, damages and interest. In so far as Mushroom Days has already received payment, Mushroom Days is entitled to retain the monies received.
3. In the event that at any time after the conclusion of the participation agreement Mushroom Days has valid reasons to fear that participation in Mushroom Days 2026 by the exhibitor will in any way damage Mushroom Days, Mushroom Days 2026 or other exhibitors, Mushroom Days is entitled to dissolve the participation agreement. The exhibitor shall remain liable for the full participation costs and other costs incurred by or on behalf of Mushroom Days in connection with his participation, without prejudice to the right of Mushroom Days to claim costs, damages and interest.
4. Cancellation or dissolution on the grounds of this article shall never constitute grounds for compensation by Mushroom Days to the exhibitor of any kind.

#### Article 8 Exhibitor cards

1. Mushroom Days sets the entrance fees for Mushroom Days 2026.
2. Mushroom Days issues construction stickers to persons charged by the exhibitor with work in his stand space. The stickers are company specific.
3. During the periods in which the set-up, maintenance and clearance of the stand space takes place, one has access to Mushroom Days 2026 on presentation of a valid construction sticker.
4. Mushroom Days issues to the exhibitor free exhibitor cards or -badges and -bands for the benefit of the exhibitor and his staff.
5. During the set-up period, the opening hours and the clearance period, access to Mushroom Days 2026 will be granted on presentation of a valid exhibitors' card.
6. Mushroom Days is at all times entitled, for sound reasons, to withdraw service- and exhibitor cards and to deny the person(s) concerned access to Mushroom Days 2026.

#### Article 9 Construction and equipment (general)

1. The exhibitor is obliged to build and set up his stand or have it built and set up during the designated day(s) and times with due observance of the stipulations of the Mushroom Days 2026 organization.
2. In setting up the stand space, the exhibitor is obliged to comply with the provisions of these regulations, other (safety) regulations issued by Mushroom Days, the regulations and instructions issued on behalf of the organization of Mushroom Days 2026 and government and fire regulations.
3. Mushroom Days may, in order to achieve unity in the set-up, issue special regulations. These regulations may also relate to the supervision of stand construction and layout.
4. In the event that, in the opinion of Mushroom Days, the set-up and/or construction of the stand space is unlikely to be completed in time before the end of the set-up period, Mushroom Days can take whatever measures it deems necessary at the exhibitor's expense and risk.
5. All costs, including the costs of raising the floors of other stands, in connection with the flushing of the water pipes for the exhibitor's stand, are at the expense of the latter.

#### Article 10 Stand construction and set-up for exhibitors with Mushroom Days stand construction

1. Exhibitors will receive the stand space including standard stand construction unless otherwise stipulated in the participation agreement. The exhibitor must apply to Mushroom Days for utilities and they will be charged separately.

#### Article 11 Unsafe situation

1. In the event of (an) (imminent) unsafe situation, disturbance of the peace, commotion and/or nuisance, Mushroom Days is entitled to take all such measures as Mushroom Days deems necessary at the time, including the (complete or partial) shutting down and/or termination of Mushroom Days 2026 and/or immediate unilateral termination of the participation agreement.
2. In the event of (an) (imminent) unsafe situation, disturbance of the peace, commotion and/or nuisance as described in subsection 1 of this article due to the actions of the exhibitor, the exhibitor is liable for the costs incurred by Mushroom Days as a result and for the (other) damage suffered by Mushroom Days as a result. The exhibitor indemnifies Mushroom Days against claims from third parties in this respect.

#### Article 12 Force majeure

1. Mushroom Days is not obliged to comply with its obligations arising from the participation agreement if Mushroom Days is prevented from doing so due to force majeure.
2. Force majeure as referred to in the previous subsection shall be understood to mean all external causes beyond the control or action of Mushroom Days, as a result of which timely, full or proper compliance with the participation agreement is no longer possible. Force majeure includes but is not limited to strikes, government measures, non-fulfilment (in time or in full) by third parties, the consequences of epidemics and pandemics (including the corona pandemic), wars, (economic) crises etc.
